Monday, April 26, 2021 – 5:30 P.M.**

This meeting is recorded by video and audio in accordance with state Open Meeting Law. Consistent with the Governor's orders suspending certain provisions of the Open Meeting Law and banning gatherings of more than 25 people, this meeting will be conducted by remote participation. The public may not physically attend this meeting, but every effort will be made to allow the public to view and listen to the meeting in real-time.

Additionally, all votes taken by the Gloucester Human Rights Commission during this and future remote meetings will be by roll call vote. If you are calling in on a phone you can press Star 9 (\*9) to request to speak. If you are watching on a computer or device there is a "raise hand" button that you can tap or press to request to speak. Please use either of these options during oral communications to be recognized to speak.

All members of the commission should turn on their video if possible when voting so that their faces can be seen. If voting by video, members should turn their video on when they vote. If voting by phone, members must first identify themselves. NO voting by text or in any other manner (ONLY by video or verbally by phone). Members of the public who speak at the meeting must provide their name and address in order to speak on any matter that comes forward on the agenda.
