

NOTICE: All disabled veteran and handicapped person parking spaces listed and designated by address or location in this section shall be deleted from this section and from this Code of Ordinances effective with the December 2015 Code supplement and shall be added to the City of Gloucester Traffic Commission Regulations known as the “List of Parking Areas Reserved for Handicapped Persons and Disabled Veterans in the City of Gloucester found herein below:

Sec. 22-287. – Disabled veteran, handicapped parking.

The locations reserved as parking areas for handicapped persons and disabled veterans shall be those approved by the traffic commission in accordance with sections 22-37 and 22-175 and published as the “List of Parking Areas Reserved for Handicapped Persons and Disabled Veterans in the City of Gloucester” and those locations listed herein, and shall be enforced when official signs are in place giving notice thereof.

Dale Avenue, easterly side from a point of 46 feet from its intersection with Warren Street for a distance of 44 feet (22 feet per space) in a northerly direction and replacing meters #5 and #6, two spaces. Signs reading “City Hall Use Only” shall be erected for each space

Dale Avenue, easterly side, from a point 90 feet from its intersection with Warren Street, for a distance of 22 feet in a northerly direction which shall be enforced as two-hour parking only from 7:00 a.m. to 8:30 p.m.

Dale Avenue, easterly side, from a point 136 feet from its intersection with Warren Street, for a distance of 22 feet in a northerly direction.

Dale Avenue, westerly side from a point beginning 120 feet from its intersection with Warren Street for a distance of 24 feet in a northerly direction (the space between the crosswalk and ten feet from fire hydrant)

Duncan Street #25, one space

East Main Street #267, two spaces in front of the Gloucester Stage Company, to be utilized during events held at the Gloucester Stage Company only. Temporary, portable signage to be provided by the department of public works to be kept and maintained by the Gloucester Stage Company

Lexington Avenue, easterly side in a southerly direction from the corner of Norman Avenue and Lexington Avenue for a distance of 58 feet, one 19-foot space, with white stripe; new ramp, no parking
Lexington Avenue, westerly side in a southerly direction for a distance of 30 feet from utility pole #4705, imprint white lines for a distance of 19 feet at curb ramp. Move existing handicapped parking space three feet forward in a southerly direction, from utility pole to handicapped sign is 68 feet
Lexington Avenue, westerly side beginning at a point 170 feet perpendicular to the wall at 89 Lexington Avenue from its intersection with Shore Road for a distance of approximately 22 feet more or less, in a northerly direction
Liberty Street #4, one space
Madison Avenue #14, one space

Madison Avenue #20, 20 feet from its intersection with Washington Street on the westerly side, one space

Main Street #186, one space

Main Street, in front of #122-#124, one space

Main Street, southerly side, 199 Main Street, at crosswalk, directly across from Elm Street

Main Street #287, one space approximately 20 feet in an easterly direction on the southerly side of Main Street, just before the entrance of the Gorton's satellite lot

Maplewood Avenue, from 30 feet from the intersection with the southerly side of Cleveland Street, in an easterly direction for 20 feet, one space, with the sign being mounted on the existing "Slow Children" signpost

Mason Street, westerly side, beginning at a point 130 feet north of its intersection with itself, then 140 feet east of its intersection with School Street, for a distance of 22 feet

Mason Street, in front of #16, one space

Middle Street (in front of YMCA), southerly side, from a point of 20 feet from its intersection with Hancock Street for a distance of 22 feet in a westerly direction

Niles Beach parking lot, two spaces designated as handicapped parking
