FURTHER ORDERED that in accordance with the changes in the State Election Laws, Chapter 255 of the Acts of 2020, as amended by Chapter 5 of the Acts of 2021 on July 29, 2021, that the City Council evaluate and report on whether such change would have a disparate adverse impact to the polls on the basis of race, national origin, disability income or age, and not later than 3 days prior to changing a polling place, and make publicly available on the City's website and at the office of the city clerk a report on its evaluation; AND

FURTHER ORDERED that this matter be referred to the Ordinances and Administration Standing Committee for review and recommendation to City Council.
