## Operators

- Operators shall be courteous and respectful to passengers
- Operators shall operate the launch safely at all times
- Operators shall respond to request for pick up with an approximate ETA
- Operators shall suspend launch service during dangerous weather events
- Operators shall inform awaiting passengers of expected length of weather delay
- Operators of the launch can refuse service to anyone whose footwear or attire will stain or damage the launch in anyway
- The operator as the Master of the vessel has final say on ridership
- The operator is overall responsible for the conduct and safety of all passengers and crew
- In the event the launch is down for unexpected repair or service the department will attempt to notify passengers in advance

## Passengers

- Passengers shall pay in advance for the use of the launch service
- Passengers shall follow all directions from the launch operator who is the USCG Licensed Master of the Vessel
- Passengers shall embark and disembark at the direction of the launch operator and in a safe manner
- While in transit passengers shall remain seated at all times unless otherwise directed by the launch operator
- Passengers shall be prepared for suspension of service due to sudden weather events
- Passengers shall at all times behave in a civil manner toward the other passengers and the operators
- The launch operator can refuse service if a passenger appears impaired or intoxicated
- Passengers can be refused service for unsafe or belligerent behavior
- Parents shall be responsible for their children's behavior and safe conduct
- In the event the launch is down for unexpected repair or service the department will attempt to notify passengers in advance
- The Master of the vessel has final say on ridership. The Master is overall responsible for the conduct and safety of all passengers and crew
- Failure to follow any of these rules or regulations could be grounds for suspension/revocation of season passes or launch riding privileges.
